- Community College of Rhode Island(CCRI) acknowledges it signed and returned to the U.S. Department of Education the Certification and Agreement forms, and gives the assurance that CCRI intends to use no less than 50 percent of the funds received under the CRSAA and ARP (a)(1) programs to provide Emergency Financial Aid Grants to students.
- The total amount of funds CCRI received pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) programs is as follows: \$5,000,285 CRRSAA \$19,365,861 ARP
- 3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and programs for the quarter ended 6/30/21 is \$1.204.366.
- 4. The estimated total number of students at CCRI eligible to eligible to receive Emergency Financial Aid Grants under CRRSAA and ARP (a)(1) and programs is 22,463.
- 5. The total unduplicated number of students who received an Emergency Financial Aid Grant under the CRRSAA and ARP (a)(1) programs for the quarter ended 6/30/21 is 2156.
- 6. The methods used to determine which students receive Emergency Financial Aid Grants and how much they would receive under under the CRRSAA and ARP (a)(1) programs for the quarter ended 6/30/21:

The following eligibility criteria apply:

- All CCRI students enrolled since the beginning of the national emergency on March 13, 2020 can be considered for funding as of the date of the receipt of HEERF III on May 17, 2021.
- Prior to May 17, 2021, to qualify, students needed to be currently matriculated in an eligible CCRI degree or certificate program.
- Students who are file the Free Application for Federal Student Aid (FAFSA) and have an estimated family contribution (EFC) within the range of eligibility for the Federal Pell Grant are determined to demonstrate the greatest amount of financial need. These students enrolled for Summer 2021 were directly granted the following amounts in emergency grant assistance:

- \$1000 for full time students
- \$750 for ¾ time students
- \$500 for all students enrolled in at least one but fewer than 9 summer credits
- All other enrolled students who did not receive direct grant assistance, yet demonstrated significant need, were able to apply for emergency grant assistance through 2 online applications: one for a general emergency grant and the second specifically for technology grants. The applications will remain available until funds are depleted.
