Agenda Item 3) Welcome: Director of Information Security – David Rowbotham

- Discussion:
 - Representative Gudeczauskas welcomed David Rowbotham, Director of Information Security. Representative G gave David an overview of the responsibilities of the Technology and Data Committee.
 - David Rowbotham introduced himself, providing his background and role at CCRI.
 - All TDC members and subject matter experts introduced themselves.

 - A few edits were made by David in terms of right use of language.

Agenda Item 5) Proposed Software Support Policy

- Discussion:
 - Representative Gudeczauskas mentioned we want to have the policy provide a link to a webpage listing all software, rather than keeping the list in the policy that will need to be continuously updated.
 - Representative Novell mentioned the need for this policy came out of no one truly knowing what software available for use, who can utilize what, and how to implement best practices around what software is available.
 - Richard Saladin asked if this policy is for staff and faculty/endpoints or enterprise software.
 - Representative Gudeczauskas mentioned the policy will need to have different levels, including both enterprise and individual software.
 - MaryAdele Combe mentioned our use of academic software such as Blackboard, Medial, etc. would these be addressed in this policy if it is outside of IT? Are we embracing the entire community or only software that IT supports?
 - David Rowbotham mentioned this policy looks like it is focused solely on IT; asked if we have an overall organization governance policy that covers all software. Governance model typically has a list and who is responsible for each software. Should have overall organization policy, then individual departmental policies that would help define processes for software engagement including requests, support, etc.
 - Representative Novell asked what departments manage software outside of IT.
 - Student Affairs has Starfish, Signal Vine, Qualtrics, Tableau, etc.
 - Academic Affairs has APS, CourseLeaf, Labster, Blackboard, etc.
 - Representative Gudeczauskas mentioned departments have involvement with dayto-day use of software; IT has involvement of software development and implementation.
 - Representative Gudeczauskas suggested to develop college-wide policy, then individual policies for each department.
 - Webpage should include Full Support; Limited Support; and Departmental Support lists of software.
 - Phil Gordon asked how a new software gets onto a particular support list or how does a software move from limited to full support or vice versa.
 - David Rowbotham mentioned he envisions a governance side and software support side.
 - Representative Gudeczauskas mentioned having a subcommittee that sits under the TDC to do quarterly checks of software and determine end-of-life of software to keep webpage updated.
 - Lauren Webb mentioned her interest in process of software and how most are cloud-based with limited support. It would be helpful to have a process for identifying when a site-wide license is needed for certain software.



- Representative Novell added a line in the draft policy to address software support changes.
- David Rowbotham to share a few governance policies as examples. IT should be looking at software and policies with regard to regulatory compliance.
- Representative Del Sesto will create a folder in the OneDrive for software support, including the current Software Support Policy and draft Supported Software Publication Policy, for comments and edits to be made by the committee and subject matter experts.
- Representative Novell mentioned the Software Support Policy should be separate from the Supported Software Publication Policy based on the substantial revisions needed for the Software Support Policy.
- Richard Saladin asked what the expectation is for cloud-based software support.
