learning and formal academic course work. Additionally, this position provides academic tutoring and technical assistance support (ENG/Spanish) to all RIECETP students enrolled in the 12-credit and CDA training programs

- Record and report student participation and outcomes data
- Maintain time and effort reports

- Coordinate with RI TEACH manager and staff to report and track CDA student progress, assist CDA students to follow through with initial TEACH and CDA application and renewal process and IPDP development
- Assist with other RIECETP administration program activities as needed
