#### **JOB SUMMARY:**

Reporting to the Dean of Learning Commons and Classroom Technology of the Community College of Rhode Island (CCRI), the Executive Director of Online Learning has a vital role for the development, management, and quality assurance for online courses and programs. The Executive Director serves as the primary administrator responsible for ensuring that online courses and programs meet quality assurance metrics, accreditation standards of the regional accreditor NECHE, and national regulatory compliance requirements including NC-SARA. The Executive Director will lead the development, implementation, and assessment of online courses and will focus on both quality and innovation in online learning. This role will be involved in the strategic planning for online programs and will implement market research in collaboration with key stakeholders to review future program opportunities.
