3. REPORTS OF LEADERSHIP COMMITTEE

Announcements and Report of the Chair - Senate Chair Sneesby

- Senator Austin has agreed to take the lead on starting and maintaining a Senate history and archive. He has started collecting and saving artifacts about our body and will continue this work throughout the year.
- Senator Friel has agreed to take on the duties of secretary on a consistent basis. This will
