Updates from Chair Luzzi-Sneesby:

1. We have now joined the National Council of Faculty Senates

- 2. The senate should be prepared to consider additional meetings on 04/14/2021 and 04/28/2021 from 3:30 5pm.
- Luzzi Sneesby has reached out to the adjunct faculty association to discuss the Senate and the
 role that the adjunct faculty may play. The Senate Chair and Vice-Chair met with the President of
 the adjunct faculty association. Research shows that many faculty senates have some form of
 adjunct representation.
- 4. Luzzi Sneesby is willing to testify at the General Assembly regarding RI Promise and a resolution of support for RI Promise will be put before the senate for consideration.
- 5. President Hughes has agreed to participate in the Faculty Senate and attend future senate meetings.

Remarks from College President Meghan Hughes:

- 1. President Hughes welcomed the formation of the Faculty Senate and is looking forward to working with Senators to improve the governance of the college.
- 2. President Hughes would like the senate to consider bringing in a specialist (consultant) to assist the senate as it gets going.
- 3. President Hughes reiterated her support for RI Promise and hoped the senate would support the program, as well.
- 4. President Hughes reviewed some of the metrics and successes of the RI Promise program.
- 5. President Hughes will soon be meeting with the new governor to discuss RI Promise and other funding issues.
- 6. President Hughes believes that the college has broad support, overall, in terms of funding and its mission from within the General Assembly.

Remarks from Vice-President Rosemary Costigan:

- 1. VPAA Costigan made brief remarks and reiterated the items mentioned by President Hughes.
- 2. VPAA Costigan congratulated the senate on its formation, especially during Covid-19.
- 3. VPAA Costigan outlined her support for RI Promise.

Senator Ulricksen promised that motion only allows the leadership committee to meet with potential consultants and negotiate on the scope of work. A final decision would be made by the full senate.

Others pointed out that while the program is not perfect, it does provide significant help to many of our students and promise students make up a significant percentage of the enrollment at the college.
